IX. David Hik Update

a. David has accepted a lead position with Polar Knowledge Canada, the Government of Canada agency that coordinates arctic research for the country. Moving to Cambridge Bay to work at the New High Arctic Research Station.

X. Faculty of Environment Update, Dongya Yang

a. Most of their collaboration has moved online, but some faculty members are hoping to travel later in the year or early next year and the recommendation is for them to make these plans, in case there is an opportunity.

XI. National Security Guidelines, Donya Yang

- a. Forwarding concerns from researchers who are collaborating with people in other countries and are now required to complete the new risk assessment form. A request for the University to develop some guidelines to help address those concerns.
- b. Federal government has been under a lot of pressure about university research partnerships. The federal government is so far only requiring this new assessment for the NSERC Alliance and only companies and only for relationships for which there is a contract.
- c. The Federal Government wants us to take risk assessment very seriously, use these tools and framework broadly to encourage this practice..
- d. This is an effort to provide a risk assessment for the protection of intellectual property.
- e. ORS is taking the lead on making sure we can still submit our proposals and proceed. ORS helps us build
