#### **PROGRAM CHANGES**

#### a. Faculty of Environment (SCUS 21-57)

1. School of Environmental Science

#### Motion 1

It was moved by P. Kingsbury and seconded by A. Parmar

"that SCUS approve under delegated authority and send to Senate for information the changes to description and the upper and lower division requirements, effective Summer 2022, for the:

**Environmental Science Major** 

Environmental Science Honours."

There was brief discussion regarding the changes to these two programs with focus on the addition of the general concentration in the Environmental Science Major.

P. Kingsbury explained that the majority of students do not declare a concentration and the general concentration will allow students to choose from a broader set of options.

Committee members made recommendations to clarify the Calendar language, as it wasn't evident how students navigate the program.

P. Kingsbury agreed to take the item back to the UCC for revisions and forward on to the secretary of SCUS for approval at the next Senate meeting in September.

analysis of the impact of our transcripts for current and former students

It was suggested by the Secretary, in terms of gathering data, to also consider reviewing graduate school admissions averages and how SFU students are evaluated/admitted relative to other institutions. He noted that it's up to the graduate school to ensure that the admissions criteria are standardized for all applicants.

There was much discussion comparing the advantages and disadvantages between percentages and letter grades on a transcript. All agreed that a standardization is needed as there are different gradings practices within faculties and programs.

The general consensus was in support of gathering more information and moving forward with this project to determine if a change is needed to revise student transcripts and grading system to accurately show a student's academic standing and success, and how to use those grades to their advantage in their future endeavours.

The Vice-Chair concluded that she will consult with the Registrar about how to move forward with this project, to gather information for analysis on what other schools do with their transcripts, whether SFU students may be disadvantaged as a result, and see if there is capability for the recommended modifications.


## **b.** Future SCUS meetings

## 1. Course Units

The Vice-Chair began the meeting by sharing the discussion notes from the last Policy Meeting regarding the principles and definitions of a course unit.

#### **PRINCIPLES**

With blended courses and online courses, the issue is not just about the number of contact hours; it's about workload

A 15-unit load should fit within an average work week (i.e. 40 hours of total work or 8 hours per class on average)

#### **DEFINITIONS**

There was discussion and feedback provided regarding various definitions and which fit best with SFU students and faculty:

Based on Concordia's definition, assuming a 15-week term including the finals week Based on 10 to 12 hours per week Combination of other institutions' definitions

E. Elle will send an updated document to the committee based on revisions made at this meeting and will draft a memo to bring to the September SCUS meeting for further discussion.
