#### 1. APPROVAL OF THE AGENDA

#### 3. CHAIR'S REPORT

The Vice-Chair provided an update on the General Education project, noting that consultations are closing down November 15 and the committee will be making changes in response to the feedback received. Information will be brought to SCUS for review before it goes to Senate for information.

There was a question raised regarding a timeline of the general education project. The Vice-Chair explained that they are hoping to begin the recertification process early Spring 2023.

C. Murray provided background of the new course proposals with more attention to URB 499. She explained that URB 499 was initially developed for an undergraduate accelerated degree program and subsequently now collaborating with the Faculty of Environment and the Department of Geography, in introducing a forthcoming major.

- C. Murray explained that there is currently a Letter of Intent stating that an MOU will be established but since the election, change in council and mayor, negotiations are still in progress.
- J. Sutherland reminded everyone, when moving through negotiations related to MOUs, to include the Office of the University Curriculum and Institutional Liaison and the Office of the Provost and Vice-President Academic in the correspondence and discussions, as MOUs require Provost approval. She also reminded the committee members that until any new course proposals or new programs are approved by the Ministry of Education, there should be no posting or public communication about them until that approval is received.

There was much discussion regarding the proposed graduation requirement changes for the School of Criminology. The main concern was the calculation of CGPA and the language used to define the graduation requirement changes.

- J. Sutherland clarified that the University calculates program GPA on the requirements for the program not every course completed within that acronym. She noted that for most students, this makes no difference as overall it minimally affects their program cgpa but for honour students and for students on the cusp of meeting the minimum graduation requirement of 2.25, it often skews them lower which takes them longer to increase their program cgpa.
- C. Murray provided information on the rationale of this agenda item which is in response to the over enrollment of this program, explaining that the intent is to streamline this process of degree completion and clearly define gradhetsmarchy21fenfacts(1fn)21fedfs(1fn)21f
