a. Duolingo English Test (DET) (SCUS 21-15)

Motion 11

It was moved by K. Verkerk and seconded by E. Park

"that SCUS approve and recommend to Senate the extension of the Duolingo English Test pilot on an interim basis (Fall 2021 through to Fall 2023; spring, summer and fall term."

CARRIED

K. Verkerk provided background information of the Duolingo English Test (DET), which was approved as a pilot option to satisfy the English Language Requirement for undergraduate admission last year. She added that with the continued closure of English-language test centres, an extension of this pilot is proposed for the benefit of those students in countries where no other English proficiency test is available. This will also allow further data collection of student academic performance to determine whether the DET could be an ongoing option for undergraduate admission at SFU.

b. SCUS – Annual Report (SCUS 21-16)

K. Nordgren provided an overview of the SCUS annual report, which will go to the March Senate meeting for information.

The Chair noted that it is not often reported that more courses are deleted than created in a given year and congratulated the Committee on their hard work over the past twelve months as reflected in the annual report.

1. <u>Elective Grading System Implementation and Policy</u>

Motion 11

It was moved K. Verkerk and seconded by M. Pinter-Collett

The Chair thanked D. Shafey and others who worked on the policy documents, which will be forwarded to the next Senate meeting for approval.

K. Verkerk and D. Shafey provided information on the significant changes and answered questions from the committee members.

This item was tabled due to time constraints as further discussion was needed to finalize the details and clarity of the proposed language and criteria.

(Note: voting on this item was conducted by electronic voting, following the meeting).

There was much discussion with concerns regarding the number of allowed repeats and implications that may occur. Some of the concerns/comments related to the criteria were:

- The potential for students to take advantage of unlimited repeats, if a specific limit was not included
- The lack of consistency across the university in terms of approving repeats in excess of the current limit
- Providing a mechanism for approving repeated courses above the current limit in order to check in on the student's progress
- If students were in academic difficulty prior to pandemic, should there be exceptions/limits
- Will this reduce the burden on advisors?
- Should there be a specific timeframe, e.g. between Spring 2020 and Fall 2021, to align with the pilot grading system?

All agreed to keep the policy as is, but to incorporate a limit of repeats specific to the period from Spring 2020 to Fall 2021 within the policy.

d. Minimum Prerequisite Grade – Edits to existing courses (For Discussion) (SCUS 21-18)

K. Nordgren spoke to this agenda item, stating that there are programs in the Calendar that have identified minimum pre-requisite grade requirements of C minus or higher; however, these requirements are not specified on individual courses within the Course Catalog/Calendar. This discrepancy causes issues for the Scheduling department, which is responsible for coding prerequisites, and for students and staff who are unclear on these requirements. He asked the SCUS committee members if they would approve edits to be made to their programs to address this issue, which has been done in prior years.

All agreed to have Student Services proceed with the program/course editorial updates.
