- 1. Tuition and Fees.
 - a) I will pay tuition and other feesquivalent tomy applicable programomination by the required deadlines, as per below.
 - i. For a full-time program (FEP 200): I will continue to pay all tuition (domestic and international rates apply), supplementarys and special fees to SFU (including any co-op feesanddistancæducatiorfee,if applicable) and will be exempte from paying tuition to the host institution. I will be paying tuition fees equivalent to twelve (12) units (for a tweeterm exchange, I illy pay twelve (12) units in each term, for a total of 24 units).
 - ii. For a short-term summer program (FEP course varies base con number of units): I will continue top ayall tuition (domestic and international rate sapply), supplementar fees and special fees to SFU (including anyopofees and distance education fee, if applicable), and will be exempted from paying tuition to the host institution. I will be paying units at the normal domestic or international rate aspplicable for a sort-term summer program (based on maximum XQLWV DYDLODEOH SRVWHG RQ,66¶V H[FKDQJH SURJUD

- d) As an exchange participant, enrolment in my FEP or GLP course alone does not make me eligible for the U-Pass Program for the term of my exchange enrolment.
- e) I will be charged a \$300.00 non-refundable, Formal Exchange Participation fee per nominated institution (as of the 2025/26 academic year) to my SFU student account. I will not be charged

I understand that participation in an exchange program during my final term of study at SFU is not recommended and, due to exchange credit processing, will likely result in a delay in my graduation.

- n) If, after consulting my academic program advisor(s) I pursue a course on exchange with the intent of fulfilling a Writing, Quantitative, or Breadth (WQB) requirement, I am responsible for submitting a request for each WQB Evaluation to Institutional Liaison (UCIL) Office and consulting with UCIL office, if needed, on whether courses I take on exchange are eligible for WQB designation. - o) I understand that the host term dates may be different from is necessary for me to arrange for exam invigilation in order to complete my exchange term, I will be responsible for making all arrangements through an external exam invigilation servic 0 612 406.15 1 11.04 Tf1 0 0 1 280

- i. **Student Aid Mobility Contract:** I understand that I must successfully complete and transfer the equivalent of at least 60% of a full-time course load, which is 9 SFU units. I may be required to provide proof of my enrolment to SFU.
- ii. **Student Aid Completion of Studies form:** I understand that I am responsible for having my host institution sign my Completion of Studies form before returning to SFU, if applicable. I understand that not submitting this signed document to FAA upon my return may impact my future government-issued student financial assistance eligibility. In the exceptional case my host institution is unable to complete my Completion of Studies Contract, FAA requires a copy of an official transcript from my host institution as a proof of my enrolment and successful course completion. I consent to ISS releasing a copy of my official transcript from my host institution and that it is my responsibility to communicate if there are delays in providing this information to FAA.
- d) **Government-issued student financial assistance (part-time):** I understand that if I require government-issued student financial assistance (part-time student loans and grants or part-time in-study, payment-free status), I must complete and submit the following documentation with a copy of this Acknowledgement to FAA:
 - i. **Student Aid Mobility Contract (Part-Time):** I understand that I must successfully complete and transfer the equivalent of between 20-59% of a full-time course load, which is 3-8 SFU units. I may be required to provide proof of my enrolment to SFU.
 - ii. **Student Aid Completion of Studies form:** I understand that I am responsible for having my host institution sign my Completion of Studies form before returning to SFU, if applicable. I understand that not submitting this signed document to FAA upon my return may impact my future government-issued student financial assistance eligibility. In the exceptional case my host institution is unable to complete my Completion of Studies Contract, FAA requires a copy of an official transcript from my host institution as a proof of my enrolment and successful course completion. I consent to ISS releasing a copy of my official transcript from my host institution and that it is my responsibility to communicate if there are delays in providing this information to FAA.
- e) For a **direct fee-paying program**: I understand that I will not be enrolled in any units at SFU for my participation in this program. Participation in this program will not count towards FAA eligibility at SFU and I understand that this program may not be eligible for government-issued student financial assistance. I recognize that I am responsible for obtaining advice and information about what types of student financial assistance (institutional-based funding such as scholarships, bursaries, etc., as well as government-issued student financial assistance) I may be eligible for at my direct fee-paying (GLP) host institution.
- f) If I enroll in additional SFU courses in the same term as my exchange, I should contact FAA to discuss my funding eligibility.
